

# SELF DRIVE VEHICLE INSURANCE DECLARATION FORM AND PROPOSAL

## SPECIAL CONDITIONS

The Vehicle shall only be driven by the Hirer and/or any other driver/s who shall have been agreed upon before the commencement of the period of hire and completed a proposal form. The Insured hirer or driver further agrees to protect the interests of the insurance companies during the term of cover by:- 1) Co-operating fully with the insurance companies, 2) making every endeavour to obtain names, addresses of parties involved and witnesses (especially registration numbers of all vehicles involved, including witnesses' registrations and taking photographs where possible, 3) not admitting liability or guilt, 4) calling the incident line and the nearest office of the intermediaries or insurance companies as soon as reasonably practicable, 5) providing a detailed report of the accident including a diagram to the insurance companies and/or intermediaries upon request, 6) notifying the police immediately if another party's guilt has to be ascertained or if people are injured. Failure to report an accident roadside will result in a higher excess.

The Hirer will pay the amount of any excess or uninsured losses in respect of loss or damage to the vehicle and accepts the limitations of the policy as per the receipt regarding overhead damages, key security etc.
